**Population Report:** There are 236 males and 23 females for a total of 259 inmates in the Fayette County Prison. There are 8 females and 3 males out of county in Greene County Prison for a grand total of 270 prisoners.

Commissioner Zimmerlink was requesting more information, and Controller Lally was stating that no matter what the information stated, there should not be discretionary accounts.
