Chief Clerk Revak read the following announcement:

This meeting is being held pursuant to Section 1622 of the County Code entitled Salary Boards created and it reads as follows:

There is hereby created in each county a Salary Board, which shall consist of the three (3) individual members of the Board of County Commissioners and the County Controller in counties where there is a county Controller or the County Treasurer in counties where there is no Controller. The Chairman of the board of County Commissioners shall be Chairman of the Salary Board. The Board shall meet and organize on the first Monday of January of each year.
